Once a practitioner has successfully enrolled in the MII Diploma Program, he or she may apply for the Fellowship Program with the aim to fulfill the OMPT Mentorship component following successful pass of Diploma in MDT. The OMPT portion of the curriculum is designed to provide Physical Therapists with continued advanced training in examination, clinical decision-making and manual treatment skills in a concentrated clinical environment. The small group classroom and lab training sessions allow the clinical faculty to focus their instruction toward the individual needs of each fellow applicant.

Please include these additional items with Page 1 to complete your application package:

1. A copy of your active license in Physical Therapy
2. Proof of professional liability insurance
3. A copy of your MII Diploma Program acceptance letter
4. Curriculum vitae (Be sure to indicate continuing education experiences, particularly in manual physical therapy.)
5. Two letters of recommendation. (The same two letters submitted with the Diploma Program application may be used as long as one attests to the applicant's clinical competence.)
6. Description of clinical experiences as a licensed PT (*up to five years depending on experience*).
Note: Clinical experience descriptions should include the following information for each organization in which you have performed direct patient care:
 - a) Name, address, and phone number of the facility;
 - b) Name of your clinical supervisor (if any), or supervisor;
 - c) Type of facility;
 - d) Job description;
 - e) Date employed (or dates of internship);
 - f) Description of patient load;
 - g) Description of any clinical supervision or mentoring;
 - h) Time period (in hours) involved in direct patient care *for the past two years*.
Total hours = (number of hours per week) x (number of weeks per year) x (number of full time years).
7. Description of Applicant's Goals.
Please describe on a separate sheet what you wish to gain through participation in the OMPT Mentorship, your area of expertise, and your future plans in the area of Mechanical Diagnosis and Therapy and patient care.
8. As your participation in the MII Theoretical Component will involve documentation of participation in a research study, a case study with supporting references, a review of the literature pertaining to MDT or OMPT, or a written clinical commentary – we will require that you submit a copy of one of these materials before you commence OMPT curriculum.

Applications will be reviewed by a selection committee consisting of the Fellowship Program Director, Academic Advisor, and MIUSA Executive Director. The applications will be evaluated based on the following criteria:

- a) Academic education
- b) Continuing education in manual therapy
- c) Clinical education and mentoring experiences
- d) Clinical experience in Mechanical Diagnosis and Therapy and Orthopaedic Manual Physical Therapy
- e) Research experience

Applications for the Fellowship are accepted annually on a rolling basis. Notification of acceptance will be acknowledged within 30 days of the application submission. The starting date of the OMPT Mentorship Component curriculum will be determined once both Diploma components have been passed.
